### CHAIRMAN'S REPORT

Where to begin--there is plenty to say! I'll start with the AGM which was a resounding success with some sixty-seven members present (forty-three in 2004). In particular **Lorna Meadowcroft** was there and made some telling contributions to various debates. I have to believe she and Leslie were in their time a pretty potent combination. All Officers and Trustees were re-elected. Members approved by a substantial majority (three opposed) the replacement of the previous Council (All members) meetings with a half year report/debate day meeting in Manchester in October. The need to consider the revaluation of the Taylor House property was acknowledged. After lunch various policies on Wind Farms (and like structures), Open Access and s63

(Obstructions) were debated and approved. Many favourable comments were made both at the AGM and subsequently about our new style/colour Annual Report. Likewise **Signpost**, now also with colour, was found to have more impact.

Our membership just reached 1000 in April--if you are still due for renewal please do so as we want new members now joining to be additional and not replacements! Thank you.

May saw immense signpost planting activity with some ten new and refurbished placings. Two work parties in particular did sterling deeds -the first planting three

around Lyme Park (one donated by **Jerzy and Margaret Matuszewski** to commemorate 35 years of marriage). The second group put in three and a marker post near and in Tom Wood in just two hours--Guiness Book of Records please note! The highlight here was the planting of SP number 300- it has only taken one hundred years to get there but now the pace is hotting up!

Also in May we commissioned two new substantial footbridges at Greasley Hollow, Wincle which PNFS have funded for Cheshire HA and the Macclesfield Express recorded the event. This bridge initiative found special favour with member **Stanley Spearing** (93) who wants to introduce his family to walking in this area that he so loves.

The new members leaflet is up for renewal after the old one from Palmer Publishing Inc. well served its cause and **June Mabon** will lead a team of three (**June, Andy Overton and Peter Coughlin**) to execute the project. It is very pleasing to report an influx of new volunteers to Taylor House viz **David Tattersall** (email processing), **Peter Ritman** (resolving computer issues) and **Ted Wolfe** who enthusiastically turns his hand to anything and for good measure will take over some of **Maurice Deakin's** Inspector responsibilities. Thank you Maurice for all you have done for the Society. We also have four other new Inspectors coming on board via the **Hilda Bowler** finishing school namely **Harold Addie, Peter Allinson,**

**Christopher Green and Lewis Chuck.** Sadly we lose **Philip Harris** (Bolsover) due to family commitments. **Anne Palmer**, our Minutes Secretary has just relinquished her post due to just far too busy and hectic a life! Anne has made a first class contribution to the Society and will be greatly missed at Officers' Meetings. So we urgently need a replacement to take the minutes at our monthly/bimonthly meetings-- shorthand or fast writing an asset! -with the minutes then written up in draft form on a home PC. Officers' meetings are on Fridays at Taylor House from 09.30 to at the latest 12.00. You could use the August 05 meeting as a trial run -if interested kindly call me at home- 01925 762472.

Please don't forget our walks programme is up and running--last Wednesday of every month--please see walks list for July-Dec 2005 and turn up if able--leaders now sought for walks in 2006.

And finally, kindly note your Chairman occasionally does go for walkies--and plans with two or three other PNFS members to undertake the Tancat Challenge at the end of July. The walk is from Tan Hill, N Yorks (the highest pub in the UK) to the Cat and Fiddle (second highest pub) through much of our territory--the height drop is but 40 feet (1730 to 1690)---but that's after doing 126 miles in 6 days and climbing 20,000 plus feet. ## **WIND FARMS : NEW DEVELOPMENTS**

The Inspector's Report on the Public Inquiry into the proposed Scout Moor Wind Farm, north of Bury, is very fair but bad news for the opponents of the scheme. The recommendation is that permission be granted for 26 turbines 100 metres high, plus two anemometer (wind speed) towers, admin offices, access tracks and hard standing areas. All cables must be underground. Work is to commence within 5 years. The permission expires in 25 years from the date of the first electricity passing to the grid. After that time all elements of the development above ground (including access tracks) must be removed and the land restored. Presumably the concrete block 13.5 metres square at the base of each of the 26 turbines will remain in the ground, perhaps covered with turf. Note the word 'tracks'. These access roads have to be capable of withstanding the weight of the large crane required to lift the turbines into position.

Apart from this, I feel the report is very fair and accurate. The Inspector records his respect for those opposing out of a genuinely-felt love of the countryside. He is dismissive of the arguments of the three local authorities which opposed the scheme. The section which is most of interest to the PNFS states: "The moors will still be accessed by foot or by horse right up to the turbine bases. For the less agile, the unfenced tracks linking the turbines may also increase accessibility and make the moors more inclusive. For those who

appreciate the emptiness of the plateau, that pleasure will, however, be lost. For those on long distance walks or rides, they will have a different experience, but not one, I judge, that would necessarily stop them from using the western Pennines for recreation."

Other points: "Turbines will be on smooth columns with a matt finish. Open lattice work towers encourage the perching of birds. Horses should not have a problem as the turbine blades will be visible from a distance such as to allow approaching animals to get used to them."

We must now wait and see if our fears are groundless and if the government's drive for wind generation is justified. Meanwhile, Manchester Council has proposed that four large turbines be installed on buildings in the city and are encouraging developers to include turbines and solar panels in all housing projects. If you want to go it alone, British Gas has announced their production of rooftop turbines for use on individual houses. BG quotes an installation price of £1,500 for a 1 Kw (that's one kilowatt) job which will operate in a 3mph wind. They are not thought to need planning permission, but when I rang Stockport Council for confirmation I was told no policy decision had been formed.

## NEW PNFS POLICY STATEMENTS

The Officers have been working on drafting a number of 'policy statements' and have so far completed five, these cover,

- ◊ Proposals to alter the Rights of Way Network
- ◊ Alleygating
- ◊ Section 63 Orders (also includes section 56 Orders)
- ◊ Common Access Land
- ◊ Windfarms (also includes mobile phone masts etc.)

A number of these were discussed and endorsed at the recent AGM and now is a good time to start making all members aware of the statements and, of course, please feel free to let the Officers know if you have any comments.

Over the next couple of issues of 'Signpost' all of these policy statements will be covered but, limited space means that only two or three can be covered in each issue. Also the policy on alterations to the Rights of Way Network will need a full article on its own. So to get things moving here are the first three 'Policy Statements'.

### Alleygating

Alleygating is a specific type of activity that has been undertaken within urban areas to try and reduce criminal activities of various types by gating a number of passages, rear roads or roads within a given area. Although the CROW Act 2000 enacted s118b within the HA 1980 to cover extinguishment of rights on a public highway within specially designated areas of high risk it is expected that alleygating will still be seen, though on a less regular basis.

*The Society will not oppose an alleygating proposal providing,*

- ◊ *the majority of the local residents are in favour.*
- ◊ *the footpaths to be closed do not form part of a network with links to other local*

*footpaths.*

- ◊ *the footpaths to be closed are not important links for local people to amenities like schools, shops, bus stops etc.*

### Common Access Land

Now that Part 1 of the CROW Act 2000 is seeing the implementation of the rights of access to common access land it is important for the Society to make its position clear on a number of aspects.

*The general principle that the main attraction of common access land is the right to roam freely is accepted by the Society. The question therefore of new footpath provision in such areas is considered by the Society to be something that would be looked at on a case by case basis. This would also apply to new footpath provision at the points of access where currently none exists.*

*The Society would also look into any reports that it receives concerning closures of common access lands where such closures have either not been listed or are outside the permitted reasons for closure. The Society will not have a policy of inspecting or reporting on common access land as part of its normal activities.*

### Wind farms (and like structures)

The Society is always concerned to try and balance the conflicting requirements of the need to increase the

proportion of renewable electricity supply with the impact on both the landscape and the footpath network.

*The primary consideration will always be whether a proposal is believed to have a significant impact on the footpath network. The Society will therefore look at each proposal on its merits and consider each on a case by case basis.*

*These general principles will apply,*

- ◊ *how close are the turbines to any footpath?*
- ◊ *what affect does the proposal have on the quiet enjoyment of the footpath and its associated landscape?*
- ◊ *are there any incidental proposals e.g. Inclosure Act sections involving common land?*
- ◊ *do the proposed access roads cause further problems with the footpath network?*
- ◊ *what are the plans for restitution once the expected lifespan of the turbines expires?*

Please let us have your comments or suggestions.

The new footbridge at Wincle paid for by the Society and erected by Cheshire CC.




